## (RCONA Annual Elections & Banquet

Due to COVID restrictions, no banquet was scheduled to be held this year. The 2021 Executive Board Elections will proceed with minor other business. (Approval of any prior 2020 minutes and Receipt of Dec/End-of-Year Treasurer's Report will be continued to January 2021 RCONA meeting.) April was previously asked to be Secretary-Pro-Tem for this evening.

## Guest speaker: Acting Police Chief Troy Bergstrom

Acting Police Chief Troy Bergstrom attended the meeting to announce his temporary position. Troy, having been a police officer in Roseville for 21 years, was named acting police chief on Nov. 30, 2020. He is in field training until current Police Chief Maccoun officially retires as of Dec. 31st. The City has already started a recruiting process for final decision of police chief, expected to take place sometime in February.

Brief discussions were held as to:

- COVIID restrictions-City can educate businesses, but is not really enforcing restrictions.
- Houses being used for the homeless and issues involved and continuing to be investigated.
- Body cameras for the police—prohibitive costs of purchase and data storage
- April inquired about using Mark White Room at Police Department for NA meetings while schools are closed; advised police facilities are closed to public during pandemic.

#### Annual Elections for 2021 Executive Board members:

Sue Cook declared a quorum was present, 13 of the 17 NAs being represented. President Kevin LaChance named the 2021 Executive Board nominees as previously announced at the November meeting. There was some confusion as to the names stated initially, then corrected, and by a roll call vote taken as follows:

The following nominees were unanimously elected for the RCONA 2021 Executive Board: Kevin Lachance (Roseville Heights), Steve Parker (Los Cerritos, Ellen Debach (Sierra Vista, Melinda (Hawkes) Surmani (Cherry Glen), Chris Humphrey, and Scott Alvord (WestPark), and April Marskell (Blue Oaks).

Board member positions to be assigned by subsequent meeting of the new board members.

#### **New Business:**

- Kevin brought up setting up two meetings to get the new secretary and treasurer up to date with procedures. A meeting was set for December 28th at 6:00 pm with Sue, Kevin April and Ellen for Secretary. January 3rd at Noon a meeting has been set for Kevin, Chris, Melinda and Sue for Treasury.
- A separate meeting will be scheduled to handle the audit in January of 2021.

- Kevin brought up potential discussions about expanding the Executive Board to nine (9) board members; would require further discussions and notification to NAs before any Bylaws amendment.
- Ellen Debach made a motion to use unused funds allocated for the 2020 Christmas
  Party to be given to a charity of our choosing. Suggestions were discussed for the
  Placer Food Bank, Gas cards to schools for student usage, and Toys for Tots. The
  general motion (having been proposed at the November meeting) went forward as
  follow:

Ellen Debach's motion to allocate \$300 of our unused funds for Holiday Party for three schools to receive four cards at \$25.000 was seconded and approved. April will coordinate the arrangements.

The regular RCONA Board meeting adjourned at 8:25 PM.
